## **Recycling Committee Update**

Thomas Gardiner (Military retiree) has been hired as the part-time Recycling Driver. The Recycling By-Laws will be adopted at the next meeting. The county is purchasing one flatbed trailer with 20 gaylord boxes for Frederic as a trial. Grayling Charter Township, Rick Harland is now the Chairman. Lovells Township has requested a percentage for allocation this year.

## **Hospital Transfers**

Controller Compo advised that he met with Frederic EMS, MMR and Mercy Hospital regarding the policy changes. All transfers for Crawford County agencies will go through Central Dispatch beginning Monday August 26, 2013. There will be a meeting today to work out more details and the mutual aid agreement.

#### Fish Hatchery Update

The Controller advised he will seek rebids on the project for stream modification and fish passage. The County will likely lose part of the foundation grant due to not meeting deadlines and the NPDES permit is filed.

## **Audit Committee**

Currently special revenue funds are in balance. The General fund currently has a \$150,000 deficit, however, it started with a deficit of \$767,961.

<u>Commissioner Wyman</u> – The Commissioner advised the Road Commission will try some commercial brining to control road dust. Fletcher road is waiting pavement.

Chairman Stephenson reported her Law Enforcement Committee recommendation.

Motion by Lewis, second by Wyman, to authorize the Board to submit a letter of recognition to Seaman Nicole Chad on her recent Honor Cadet Award for Master-At Arms Training. Ayes (5) five, nays (0) none, absent (2) two, Motion Carried.

<u>Commissioner Munsey</u> – The Commissioner reported and placed on file her report with Library; Department of Human Services and Commission on Aging.

<u>Commissioner Anderson</u> – The Commissioner advised he has no Personnel and Labor Committee recommendations to report. The Commissioner reported that DNR Staff, Paige Perry and Todd Neiss attended Northern Counties meeting and talked about linking trails in northern Michigan. There are presently 12,000 miles in open trails through Michigan and the number is growing. The State expects to keep the trails in good condition, as annually trail permits are at 120,000 plus and trail programs generate about 5.5 million per year. The DNR continues to work in communities and with other agencies like MEDC, NEMCOG, and trail groups. Northern Michigan is blessed with some of the best trail systems in the nation.

The Commissioner reported Denise Cline from NEMCOG Northern Michigan Trails Service reported a 4 phase program, and is using US 23 Heritage Route as a model for this program as its success has made the Lake Huron route one of the most scenic in Michigan. Phase 1 and 2 are

complete through funds from USDA Mobile Visioning, they are presently working on phase 3. Phases 1 and 2 have established 5 Northern Michigan communities as a pilot project, they are Alpena, Atlanta, Grayling, Mackinaw City, and Toppinabee. The Commissioner stated that the success is due to groups working towards a common goal to make northern Michigan a great recreation place for the whole nation to come visit. You can visit the NEMCOG web site and get an overview of the program. Phase 4 is getting Pure Michigan involvement as it moves nationwide. Recognition goes out to Grayling Visitor's Bureau and State Representative Bruce Rendon for their many efforts on both programs.

<u>Commissioner Lewis</u> - The Commissioner reported his Ways & Means Committee recommendations.
